Re: Request under the Freedom of Information and Protection of Privacy Act

British Columbia Ferry Services Inc. (BC Ferries) received your request for access to records under the *Freedom of Information and Protection of Privacy Act* (the FOIPP Act) on September 11, 2024. Your request was as follows:

"Statistics and reports relating to Route 8, Horseshoe Bay to Snug Cove:

- 1. Sailing-by-sailing statistics for July 2024 showing number of vehicles, (AEQ and total vehicles and total overload), and passengers carried (total passengers, and foot passengers) in an Excel file;
- 2. Any studies, analyses, plans or feasibility reviews regarding upgrading the vessel capacity on Route 8, upgrades to the Snug Cove terminal capacity, or increases in sailing frequency (date range July 2022 to September 10, 2024);
- 3. Any long-term (i.e. time periods covering more than one year in the future) studies or analyses regarding anticipated future demand for Route 8 (dated July 2022 and July 2024)."

Enclosed please find copies of the records responsive to your request. Some of the records contain information excepted from disclosure under the FOIPP Act. This information was severed so the remaining information could be disclosed. The severed information is excepted from disclosure under sections 13 (advice and recommendations), 15 (harm to the security of a system), 17 (harm to the financial interests of BC Ferries), 19 (harm to public safety) and 22 (personal information) of the FOIPP Act. We have noted on the records disclosed to you the sections of the FOIPP Act we relied on to sever the information.
