Re: Request under the Freedom of Information and Protection of Privacy Act

British Columbia Ferry Services Inc. (BC Ferries) received your request for access to records under the *Freedom of Information and Protection of Privacy Act* (the FOIPP Act) on July 22, 2024. Your request was as follows:

"Monthly statistics from July 22, 2021, to July 22, 2024, detailing the number of passengers traveling under the Travel Assistance Program (TAP) and senior fare concessions on BC Ferries routes 1, 2, and 30. The data should be separated by route and categorized into:

- 1. TAP passengers, distinguishing between walk-on passengers and those in vehicles.
- 2. Senior passengers, further divided into those who travel for free from Monday to Thursday and those who do not.

Also, the total funds received from the BC Provincial Government in respect of travel for these passengers during this period broken out by Route and on a similar monthly basis."

Enclosed please find copies of the records responsive to your request. Some of the records contain information excepted from disclosure under the FOIPP Act. This information was severed so the remaining information could be disclosed. The severed information is excepted from disclosure under sections 15 (harm to the security of a system), 17 (harm to the financial interests of BC Ferries) and 19 (harm to public safety) of the FOIPP Act.
