Re: Request under the *Freedom of Information and Protection of Privacy Act*

British Columbia Ferry Services Inc. (BC Ferries) received your request for access to records under the *Freedom of Information and Protection of Privacy Act* (the FOIPP Act) on September 18, 2024. Your request was as follows:

*"Statistics for all routes by departing terminal showing passengers by types of passengers: personal vehicle, commercial vehicle or foot. Date range: August 1, 2022 to August 31, 2024.
Request the stats be broken down smaller than monthly, such as daily or per sailing."*

Enclosed please find copies of the records responsive to your request. Some of the records contain information excepted from disclosure under the FOIPP Act. This information was severed so the remaining information could be disclosed. The severed information is excepted from disclosure under sections 15 (harm to the security of a system), 17 (harm to the financial interests of BC Ferries) and 19 (harm to public safety) of the FOIPP Act.
